3. Agree NPAG Working Methods

Team agreed they were comfortable with the current team dynamic and make up. Meetings will be approx. every four weeks in early stages with use of email and electronic media to communicate with the group. As the project ramps up there are likely to be more frequent and ad-hoc meetings.

All NPAG meetings would be minuted. Initially minutes would be circulated to NPAG team plus copied to LLRA Chair and Vice Chair (who would be welcome to attend meetings as observers). Other future attendees would be by invitation, but the basic principle is that the NPAG team would try to accommodate community input either in NPAG meetings or separately, being aware that routine meetings will be held in NPAG members' homes.

For transparency purposes, once grants are applied for in April 2019, all subsequent NPAG meeting minutes would be visible on the long-leys.org website for the community to see. NPAG would reserve the right to redact sensitive information before making it publicly visible on the website.

The first newsletter is likely to be in the March/April timeframe when there is something that the community can respond to.

5. Potential Actions Prior To Grant Funding Being Received

Documented History of Long Leys

In the future, it may be worth appointing a volunteer historian to produce a history of Long Leys, to feed into a character assessment for the area. NPAG felt this was premature at this stage. In the meantime, Laura will investigate what City of Lincoln council have in their archives in the way of old plans/photographs of Long Leys from 1900s onwards, to include anything recorded for the 1998 urban village concept.

Approaching Major Landowners

It was agreed that Jon would draft a letter to all major landowners, for review by NPAG before sending, advising them of LLRA's designation as a Neighbourhood Forum and requesting feedback on any plans or aspirations the landowner may have for their land which landowners would like to be considered as part of the Neighbourhood Plan process.

- 14 March: NPAG Meeting and preferred date for remaining planning consultants to present proposals.
- End March: Decision on specific consultant made by NPAG and endorsed by LLRA management committee
- 1 April: Apply for appropriate grants for April 2019-March 2020. Anticipate receiving money by end April latest
- May 2019 onwards: Kick off community consultations and execute more detailed plan (avoiding local elections)
- 31 March 2020: Target for draft plan submission for local planning authority and planning inspector review
- 1 September 2020: Target date for completion of successful referendum and acceptance of plan as a planning document
