8. Improving access by footpaths and cycleways into neighbouring areas - Jon

Two requests for suggestions from the community on new cycle and footpath routes have been made. A number of ideas have been proposed by residents. Bridleways have also been added into the exercise, following a request from horse-riders.	
Local businesses will also be emailed to request their views on potential improvements.	Jon
 The main challenges for improving cycling access include: the safe crossing of barriers such as the A57 and the A46 providing alternatives to the use of Long Leys Road the low likelihood that further cycle paths could be constructed across West Common. 	

Three routes that are emerging are (see Appendix C for map):

Route 1: St George's to Carholme Road crossing.

The route could go from St George's via Albion Crescent footpath to Whitton Park, partly using existing footpaths, before crossing Long Leys Road and then westwards alongside the Common (using the strip between the fence and the hedge) until it reached the main Long Leys gate. It would then pick up with the existing multi-use path to the West Parade entrance to West Common. At the gate entrance the southern footpath running behind the rear of the houses in Hewson Road could be used to get to Carholme Road. The Long Leys Road crossing could be light controlled (ideally) or with a wider central refuge to accommodate cycles/pushchairs/mobility scooters.

Benefits: Families and children could cycle off-road from St George's to St. Faiths. A safe route could be provided to link up with the Fossdyke Navigation multi-use path to the Brayford.

Route 2: Cloverleaf Care Home to Pyewipe Inn.

The route, for horses / cyclists / pedestrians, could run alongside the drainage on the allotments in a straight line to Carholme Road. At Carholme road either a central refuge or a light controlled crossing could then provide access to the banks of the east/west drain. Two pedestrians /cycle bridges could span the two levels of the Catchwater drain and then the path could run alongside the A46 to arrive at the Pyewipe Inn with access to the National Cycle Route towards Doddington/Harby.

<u>Benefits:</u> Provide access to routes to the west and north of Long Leys, including the National Cycle Route, reducing safe walking/cycling distance from 3km to 1.5km

Route 3: From Route 2 to South Carlton

Leading north using footpath to Bishops Bridge (to A57) and then Bridleway (past A57). This is an existing route but to make it fully accessible then the dangerous crossing of the A57 at Bishops Bridge needs to be addressed. Possible options could include:

- a light controlled crossing
- central refuge for pedestrians and cyclists (horses may be more of a challenge)
- possibly a path under the bridge, similar to a canal bridge path, to allow horses/cycles to be led underneath.

<u>Benefits:</u> Better access to the north of Long Leys and existing footpaths/bridleways.

Other options have been suggested which achieve some of the same objectives – these will be added to further version of the map

(a requests has been made to the LPA to provide a map including an area 800metres to the south of plan area).

Once all feedback has been received, a small group of volunteers will be invited to review all the suggestions, before the conclusions are fed back to the community.

Approaches may also be made to cycling interest groups and possibly Sustrans.



Appendix A: Outline Project Timing Plan ver 1.5 21.8.19

- 21 May 2019: LLRA AGM, summary of initial survey findings to be presented.
- By 1 June 2019: Application submitted for appropriate grants for year April 2019-March 2020. This assumes applications open mid-May 2019.
- 8 July 2019: Anticipate receiving grant money and being able to make spending commitments. This is based on guideline 5-week timescale for time between grant application and grant approval/funds available.
- July 2019 onwards: Kick off meeting with planning consultant and development of detailed plan.
- August 2019 onwards: Community consultations start and start of execution of detailed plan
- Mid-September 2019: Draft Housing Needs Assessment (HNA) due from AECOM.
- October 2019: NPAG Newsletter and Further Community Survey to be distributed.
- November 2019: Housing requirement figure for Long Leys to be provided by LPA. HNA finalised with AECOM. Apply for Design code grant when AECOM HNA complete.
- 31 March 2020: End of grant funding year.
- 6 April 2020: Application for year 2 grant funding needs to be made.
- 13 May 2020: Year 2 grant funding assumed to be available.
- June 2020-November 2020: Date range targeted for draft plan submission for local planning authority and planning inspector review (Regulation 14 stage).
- 1 December 2020 31 May 2021: Date range targeted for completion of successful referendum and acceptance of plan as a planning document
